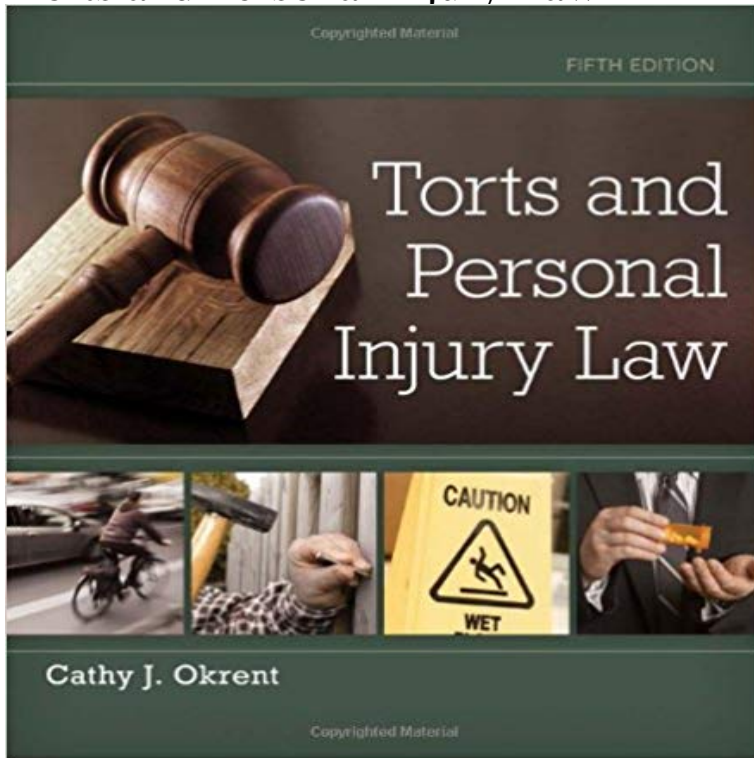


Torts and Personal Injury Law
